As per the decision taken by the Govt. of India, all the proposals for releasing of grants are to be done through NGO Partnership Portal using unique ID - Aadhaar/PAN. In this connection, you are requested to register your NGO in Niti Ayog Portal with Aadhaar seeding / PAN.

The Board had earlier forwarded emails on 1-9-2016 to those Organisations who have furnished Email IDs. However, only two organizations have furnished the Unique IDs after registration.
